

## **PRIVACY POLICY**

### **INTRODUCTION**

The "Greece 2021" Committee (hereinafter the "Committee") in its capacity as owner of this website [●] (hereinafter the "Platform"), is committed to respecting and protecting the personal data of the natural persons who come into contact with the Committee, including users submitting their proposal for the celebration of the 200<sup>th</sup> national anniversary since the Greek Revolution ("data subjects"). In this context, the Committee notifies this Privacy Policy on Personal Data (hereinafter "Privacy Policy"), which forms an integral part of the Terms of Use of the present website, with the aim to provide data subjects with adequate information on the conditions for the collection and processing of their personal data.

The Committee, under its capacity as a Data Controller, pursuant to Regulation (EU) 2016/679 (General Data Protection Regulation) (hereinafter "GDPR"), processes the personal data of the data subjects in full compliance with applicable national and EU legislation for the protection of personal data.

### **WHAT KIND OF PERSONAL DATA IS COLLECTED**

The Committee, in the context of its operation purposes, may collect the personal data of the users of the Platform, and in particular of those who submit their proposal for the celebration of the 200<sup>th</sup> national anniversary since the Greek Revolution.

The Committee may collect and process the following types of personal data:

- Personal details (such as name and surname, father's name)
- Contact data (such as address, phone numbers, e-mail address)
- Cost figures and information about the funding of the proposal (if any and insofar they involve a natural person)

### **HOW YOUR DATA IS COLLECTED**

The Committee processes the personal data provided to it (for example, when you fill-in and submit the participation form to the actions plan for the celebration of the 200<sup>th</sup> national anniversary since the Greek Revolution through the Platform here) or those collected in relation to you (for example by the user who submits a proposal through the Platform when the sponsor is a natural person) in accordance with this Policy.

### **PURPOSES & LEGAL BASIS FOR THE PROCESSING OF YOUR DATA**

The Committee in the context of its operation purposes, including the study and submission of proposals for the enhancement of the values of the Greek Nation, culture and history, as these have been formulated since the establishment of the Greek State and to date, and the formulation of the action strategy and of the actions' plan that shall take place for the celebration of the 200<sup>th</sup> national anniversary since the Greek Revolution, collects and processes the personal data above of the users who submit their proposal for the celebration of the 200<sup>th</sup> anniversary of the Greek Revolution and of any other natural persons whose personal data are included in the above proposals.

In particular, the Committee processes the personal data it collects:

(a) In the context of the submission and assessment of the proposals provided to it in accordance with the Terms of Use of the Platform in order to:

- Communicate with users who submit their proposals,
- Inform them about the progress of their application, and

- Promulgate the proposals to be included in the actions plan to be drawn up by the Committee.

The legal basis for this processing is the performance of a contract and / or the steps taken at the request of the user submitting the proposal prior to entering into a contract (Article 6(1)(b) GDPR).

(b) To comply with its legal obligations when processing is required by law. The legal basis for processing is compliance with a legal obligation of the Committee (Article 6(1)(c) GDPR).

(c) On the basis of its legitimate interests, in order to:

- Articulate and communicate its action strategy and its actions' plan,
- Communicate with users on any matter related to their application, and
- Safeguard and defend its interests and rights.

The legal basis for processing is the legitimate interest (Article 6(1)(f) GDPR).

Where the Committee processes your information for a purpose other than the above, the Committee will inform you respectively and will obtain your consent, if required.

#### **WHO ARE THE RECIPIENTS OF YOUR DATA**

Recipients of the personal data of data subjects may be the committee which is responsible for the evaluation of submitted Proposals for the celebration of the 200<sup>th</sup> national anniversary since the Greek Revolution ("Wise Men Committee") and at a final stage the Prime Minister. The Committee may also disclose information to:

- Third party service providers, who provide services on behalf of and under the instructions of the Committee, and who have committed themselves to confidentiality and to the protection of personal data in accordance with national legislation on the protection of personal data and the GDPR.
- Committee's partners, for the purposes mentioned in the present Policy.
- Any public or judicial authority where required by law or by a court decision.

#### **TRANSFER TO THIRD COUNTRIES**

Your personal data are processed by the Committee within the European Union. If data concerning you is processed in countries outside the European Union, the Committee will ensure that your personal data is processed subject to appropriate safeguards.

#### **RETENTION PERIOD OF YOUR DATA**

The Committee stores the personal data that are collected through the Platform for as long as it is required for the purpose for which these were obtained and for the period that may be required until any claims are prescribed pursuant to applicable legislation or until the irrevocable judicial resolution of any disputes.

#### **YOUR RIGHTS**

You are entitled to request access to your personal data, rectification or erasure of your personal data, restriction of processing, objection to the processing and/or to exercise your right to data portability.

You may exercise your rights described above by contacting the Committee at the contact details listed below. In case you exercise any of your above rights, the Committee shall take all necessary measures to satisfy the request within the time-limits laid down in the legislation, by informing the data subject of the satisfaction of its request or of the reasons which impede the exercise or satisfaction of such right.

You also have the right to contact the competent supervisory authority (Hellenic Data Protection Authority), which examines complaints according to the instructions provided on its website ([www.dpa.gr](http://www.dpa.gr)).

#### **SECURITY**

The Committee shall implement appropriate technical and organizational measures for the protection of the personal data it processes, such as ensuring the confidentiality, integrity, availability and resilience of the processing systems. If you have any questions about the security provided through the Platform, you may contact the Committee at the contact details listed in the relevant section below.

#### **MINORS**

If you are under the age of 15, you may browse the Platform. However, you cannot provide any information about you unless you have parental consent. The Platform is not designed for the collection by the Committee of personal data of minors under the age of 15.
